

TERMS AND CONDITIONS FOR PROMOTION ON BOSCH PROFESSIONAL POWER TOOLS ESHOP: "Durability Promotion" – purchase selected Bosch Measuring Tools and receive a Bosch GLI 12V-300 (solo) [SKU 06014A1000] for free ("**Promotion**")

1. By entering the Promotion, entrants agree to be bound by these terms and conditions (the "**Terms**").
2. The promoter is Robert Bosch Limited, a company incorporated and registered in Scotland with company number SC013418 whose registered office is at C/O Bosch Rexroth, Viewfield Industrial Estate, Glenrothes KY6 2RD ("**Promoter**").
